Call Summary
January 2010

- 1/4/10 Personnel responded with Rescue 4 (ATV) and Boat 5 (Jet Ski) to investigate a report of an object floating in the ocean near the County Park. Upon arrival, the object was identified as a palm tree. No further action was taken.
- 1/5/10 Personnel received a walk-up report of an individual stuck in an elevator at a business on Carolina Boulevard. Upon arrival it was determined the individual was trapped on the fourth floor. An elevator key was used to open the door and remove the individual from the elevator. Unit was secured and owner advised to have maintenance personnel inspect the elevator before returning it to service.
- 1/8/10 Personnel responded with Boat 1 to investigate a report of a fire on Goat Island. Upon arrival personnel assisted the homeowners with extinguishment of a brush fire utilizing buckets of water. The fire was accidental. Boat 1 returned to the marina.
- 1/9/10 Personnel responded to a report of smoke in an apartment on Ocean Boulevard. Upon arrival crews found thick smoke inside a first floor unit. Upon further investigation the source of the smoke was a heating unit malfunction. The smoke was cleared and all units returned to service.
- 1/11/10 Personnel responded to a residence on Edgewater Alley for a resident stuck in an elevator. Upon arrival the crew removed the resident from the unit. No further assistance was needed.
- 1/12/10 Personnel responded to a vehicle fire on Palm Boulevard. Upon arrival found a vehicle with fire in the passenger compartment. Crews initiated a fire attack with a 1 ¾" hose line and extinguished the fire. No one was injured and all crews returned to service.
- 1/22/10 Personnel responded to a residence on 30th Avenue for a strange odor in the building. The resident reported mixing several chemicals to remove a clog in the plumbing. Upon arrival crews ventilated the building with a positive pressure ventilation fan. Despite removing the odor the residents were advised not to stay in the residence overnight and allow for more ventilation prior to returning. No further assistance was needed and all units returned to service.

The volunteer roster is currently at 10 members.



Communication Report January 2010

January 5

Chief Graham attended the Digital Radio User Group meeting to discuss Motorola's proposal for network solution and upgrades to Charleston County's Digital Radio System. The proposed upgrades are outlined below.

Phase I

- Raise Six Mile site to 300 feet and make it simulcast
- Install a new tower IOP simulcast
- New simulcast site at the existing Crown Castle tower 2 miles south of Seewee Road
- Raise the Folly Beach tower and install a simulcast site
- Move the existing Summerville simulcast site to Deer Park

Phase II

- Install a simulcast site for Johns Island and Hollywood area SBA tower
- Install a small ASR tower at Edisto (Reusing the Six Mile Road equipment)

Phase III

- Turn the existing McClellanville site into a simulcast site
- Install a new simulcast site on upper Hwy 17 between McClellanville and Awendaw
- Install a new simulcast site on Hwy 165
- Install an ASR site at the old Summerville tower. (Reusing the McClellanville equipment)

January 5

Chief Graham and Mount Pleasant Fire Department Chief Williams met with personnel from the Charleston County Consolidated 911 Center to discuss issues related to transition into the Consolidated Dispatch Center.

January 28
