**Isle of Palms Fire Department**  
**Call Summary**  
*August 2011*

- 8/12/11 All units responded to a reported structure fire in Forest Trail. Prior to arrival, Engine 2 reported that smoke was visible. Mutual aid was requested. Upon arrival, crews reported heavy fire and smoke coming from the attic of a two-story residence. A water supply was established while size-up was completed. Two 1 ¾-inch hand lines were pulled to initiate fire attack. A 2 ½-inch attack line was pulled to assist with fire attack. Tower 1 set up to provide an aerial master stream on the fire. Once the fire was brought under control, a crew forced entry to the interior of the residence to begin overhaul operations. The State Law Enforcement Division's (SLED) Fire Investigation Team was requested to assist with origin and cause determination. Lieutenant Hathaway remained on scene to await the investigators. Once the investigation was complete, the property was secured and turned back over to the owner.
- 8/13/11 All units responded to a reported structure fire on 28<sup>th</sup> Avenue. A cleaning service employee had arrived at the residence and smelled smoke. Upon arrival, crews reported smoke showing from the residence. Crews forced entry and advanced a 1 ¾-inch attack line to the interior to extinguish the fire. Once the fire was out, crews began salvage and overhaul operations. The fire was contained to the laundry room, but heat and smoke damage was present throughout the residence. All utilities were secured. The Police Department was asked to place the residence on special patrol.
- 8/22/11 Personnel responded to a possible lightning strike at a residence on Palm Boulevard. Upon arrival, crews found an area of the roof that had been struck by lightning and found an area in the attic that had signs of burning. No smoke or fire was present. The area was thoroughly overhauled. Several electrical breakers were tripped and the resident was advised to have an electrician look at the service before turning the breakers back on.
- 8/24/11 Personnel responded to a swimmer in distress in the ocean behind Ocean Club Villas. The caller advised his son was in the water on a "boogie board" and had gone out of sight. Upon arrival, Fire Department personnel launched two jet skis and initiated a search. The U.S. Coast Guard was requested to provide a search helicopter and the Charleston County Sheriff's Office launched a boat to assist with the search. After a short search, Police Department personnel returned to the location where the swimmer was staying and found he had returned to shore. He was uninjured. All units returned to service.

### **Call Summary**

*August 2011*

- 8/26/11 Personnel responded to the area behind Seascope Villas for a report of a kite boarder in distress. Due to concerns about launching on the beach, two jet skis were launched from the Isle of Palms Marina. Upon arrival, crews attempted to obtain a visual on the kite boarder. The U.S. Coast Guard search helicopter made several passes and did not see anything from the air. The jet skis searched the area thoroughly and also reported not finding anyone in distress. All units were returned to service.
- 8/26/11 Personnel responded to a report of a surfer in distress in the ocean between 2<sup>nd</sup> Avenue and Breach Inlet. Crews arrived on scene and were able to obtain a visual on the surfer. Two Fire Department jet skis were launched from the Breach Inlet boat ramp and a command post was established on the Breach Inlet Bridge. Due to surf conditions, Sullivan's Island Fire Department was requested to launch their watercraft as a back-up team. Both watercraft were able to make contact with the surfer and assist him to shore. All units were returned to service.
- 8/27/11 Personnel responded to a report of a kite boarder in distress in the ocean near 6<sup>th</sup> Avenue. Upon arrival, crews began launching a jet ski. While launching the jet ski it was discovered the kite boarder was being assisted from the water. Personnel checked to see if he needed any medical attention. He did not need any medical attention and personnel continued out to retrieve the kite. All units cleared the scene.

## Communications Report

### August 2011

Upgrades to the Charleston County Digital Radio system remain on schedule for cut over in November 2011 for all sites with the exception of Isle of Palms. The Isle of Palms site is expected to go on line by the end of December 2011. All dates are subject to delays in the event of a natural or manmade disaster.

August 8, 2011

Chief Graham was appointed Chairperson for the newly formed Fire/EMS/Rescue Dispatch Review Committee. The Dispatch Review Committee will serve under the Operations Committee of the Charleston County 911 Consolidated Dispatch Board.

Objectives of the Dispatch Review Committee include, but are not limited to the following:

- Review select complaints specific to protocols.
- Provide routine review of response configurations.
- Evaluate the need to update the response configurations based on statistics and compliance.
- Assist in developing policies relative to the use of protocols.
- Assist with education of the line responders of the process.
- Review of all proposals for change before being submitted to the National Academy of Emergency Dispatch for review.
