## Isle of Palms Fire Department

### Call Summary

October 2011

- 10/3/11 Personnel responded to a mutual aid structure fire in Awendaw. The crew was originally requested to move up to Awendaw Fire Station No. 2, but directed to the fire scene by the incident commander. Once on scene, the crew assisted with fire suppression, salvage, and overhaul. The crew was released by command and stood by at Awendaw Fire Station No. 1. As the Awendaw units cleared from the fire scene, the crew released to return to the island.
- 10/8/11 Personnel responded to search for the parents of two children found in the parking lot of condominium complex on Palmetto Drive at approximately 6 a.m. The crews began a door-to-door check for the parents while law enforcement contacted additional departments for resources. After an extensive search the parents were located and the family was reunited.
- 10/8/11 Personnel responded to the Sullivan's Island Fire Department station to standby while they were on the scene of a structure fire. The crew stood by until Sullivan's Island could make a unit available for coverage.
- 10/10/11 Personnel responded to a building on Ocean Boulevard for a report of a person stuck in an elevator. Upon arrival the crew confirmed one person was stuck in a stopped elevator. After attempting to access the elevator car with a key, power was secured to the elevator. A second attempt at opening the elevator car door was made and was successful. The occupant was removed and did not require any further attention. The elevator was tagged out of service while the building maintenance supervisor contacted a company to come out and repair the unit.
- 10/11/11 Personnel responded to Hartnett Boulevard for a report of a tree down in the roadway. Upon arrival the crew found a large oak tree had fallen. Fire Department personnel used chainsaws to cut the tree in to smaller segments, while staff from the Public Works Department arrived on scene to haul the tree away. The road was cleared of all debris and all units returned to service.
- 10/12/11 Personnel responded to a mutual aid structure fire in Awendaw. Upon arrival the crew assisted with fire suppression, salvage, and overhaul. Once all assigned tasks were completed the crew was released by the incident commander and returned to the island.
