

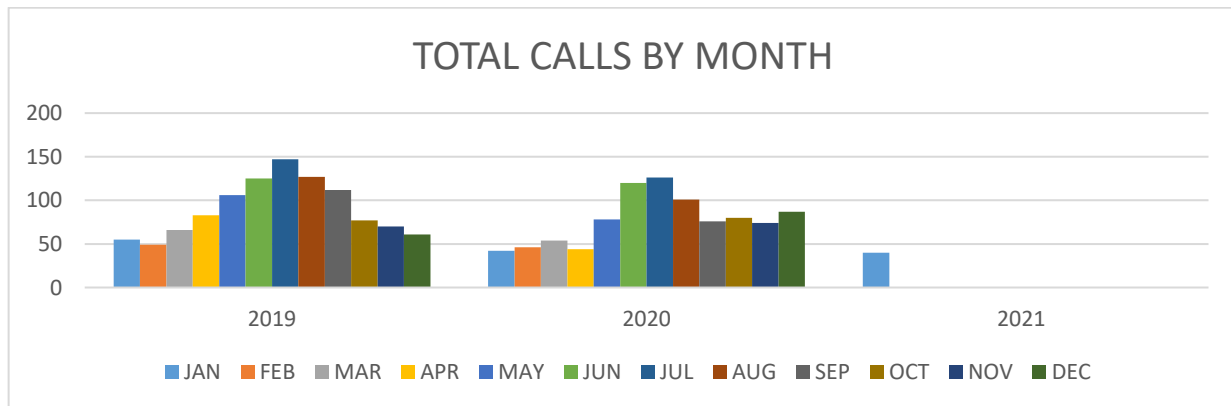

MONTHLY REPORT JANUARY 2021

NOTABLE EVENTS / CALL HIGHLIGHTS

- 01/01/2021 The Isle of Palms Fire Department is continuing to maintain situational awareness concerning COVID-19. Personal protective equipment supplies are continually inventoried and restocked as needed. Staffing is being maintained with overtime being limited as best as possible. All units cleared from the scene and returned back to service.
- 01/02/2021 Fire crews responded to a 45 foot sailing vessel that had run aground and was taking on water off the coast from Beach Club Villas. Boat 1020 and both jet skis were launched to assist with getting people off of the boat and back to the Marina. One person was brought back to the Isle of Palms Marina with two souls remaining aboard the sailing vessel to wait for Sea Tow to arrive and retrieve the Sailboat. All units cleared from the scene and returned back to service.
- 01/02/2021 Fire crews responded again to the 45 foot sailing vessel that had run aground off of the coast from Beach Club Villas. The remaining two souls that had stayed aboard to wait for Sea Tow were now in their dinghy and were requesting to be brought back ashore. Boat 1020 retrieved both individuals from their dinghy. No injuries were reported and both sailors were brought back to the Isle of Palms Marina. All units cleared from the scene and returned back to service.
- 01/07/2021 Fire crews responded to a motor vehicle accident on the Isle of Palms Connector. Upon arrival, fire personnel found that a single moped was involved with one person being injured. The driver of the moped was found on the shoulder of the Isle of Palms Connector Bridge with the moped located on the opposite shoulder. The vehicle was found to have moderate to heavy damage. The driver was treated for injuries and transported by Charleston County EMS. The moped was loaded into a fire department pick-up truck and returned to Port City where the moped had been rented from. All units cleared from the scene and returned back to service.



MONTHLY REPORT JANUARY 2021

NOTABLE EVENTS / CALL HIGHLIGHTS

- 01/09/2021 Fire crews responded to Hidden Green Lane for a possible structure fire / smell of smoke. Upon arrival personnel were met by the homeowner who stated that an electrician had been on site earlier and had been soldering some wires in the garage. Firefighters were able to find scorch marks on the particle board in the location where the electrician had been working. There were no other heat signatures found using the thermal imaging cameras. All units cleared from the scene and returned back to service.
- 01/13/2021 Battalion Chiefs Eagle, Giddens, Hathaway, and Smith attended the Supervisory and Leadership training with the City of Isle of Palms Department Heads conducted at the Riley Center in Charleston.
- 01/25/2021 Fire crews responded to Ocean Boulevard for a possible structure fire at a restaurant. Upon arrival, fire personnel noticed a smell of burned electrical components. After a thorough investigation of the premises, it was found that the wiring to the hot water heater had overheated which resulted in damage to the wires. Power was secured to the hot water heater and the manager was advised to have an electrician fix the issue. There was no fire or heat extensions resulting from the faulty wiring. All units cleared from the scene and returned back to service.
- 01/27/2021 Battalion Chiefs Eagle, Giddens, Hathaway, and Smith attended the Supervisory and Leadership training with the City of Isle of Palms Department Heads conducted at the Riley Center in Charleston.
- 01/31/2021 Fire crews responded to Carolina Boulevard for a smell of gas. Upon arrival it was found that the main gas line going into a residence was damaged by a section of fence falling onto the line and puncturing it. The gas tank was shut off at the valve and the area allowed to naturally ventilate. The property manager was notified of the issue and instructed not to restore gas to the home until the damaged line could be fixed or replaced. All units cleared from the scene and returned back to service.

NOTABLE EVENTS / CALL HIGHLIGHTS

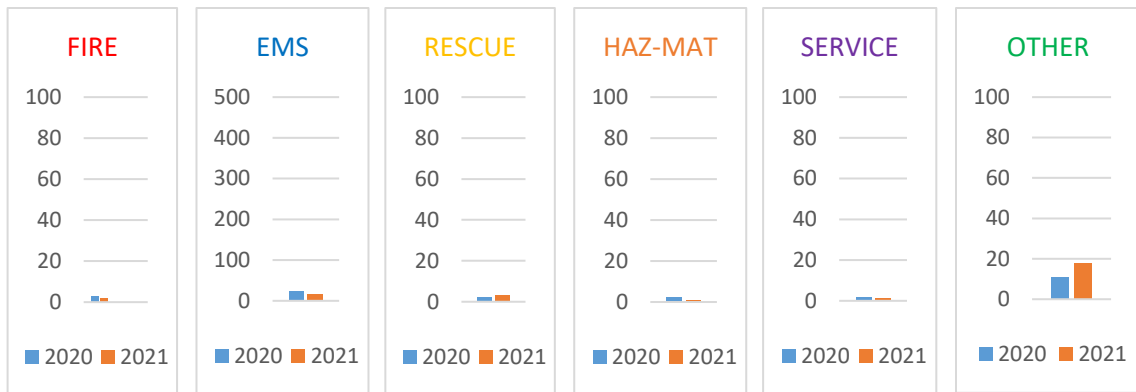
01/31/2021 Fire crews responded to the Intracoastal Waterway to search for a boater that had not returned by the time they had scheduled to return. The fisherman's truck and boat trailer were parked at the Isle of Palms Marina. Charleston County Rescue, the South Carolina Department of Natural Resources, Charleston County Sheriff's Department, and the Isle of Palms Police Department all assisted in searching for the missing individual. Fire personnel were finally able to make contact with the missing person via telephone, and water assets found the boater and helped guide the vessel back to the City of Isle of Palms Marina. All units cleared from the scene and returned back to service.

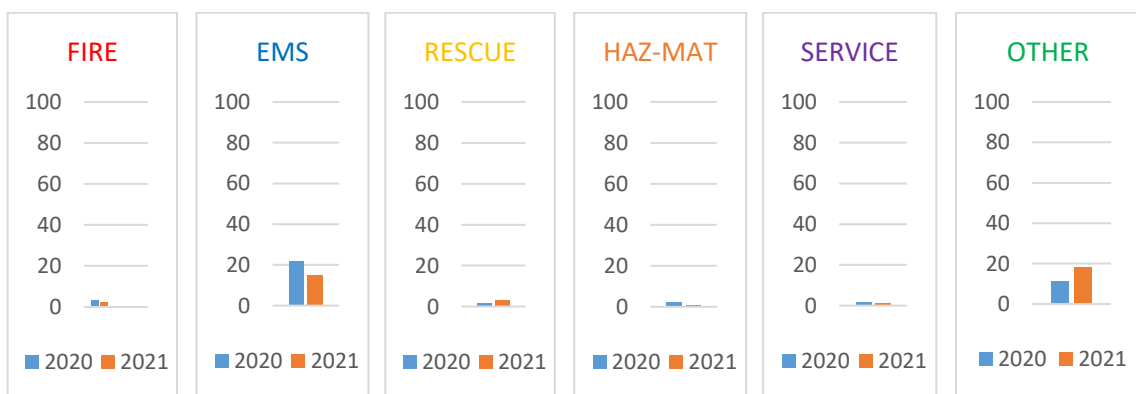

JANUARY MONTHLY ANALYTIC COMPARISONS



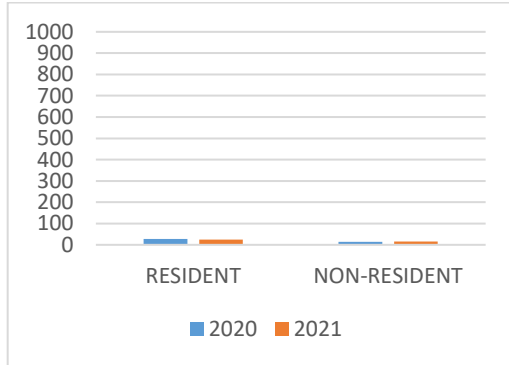

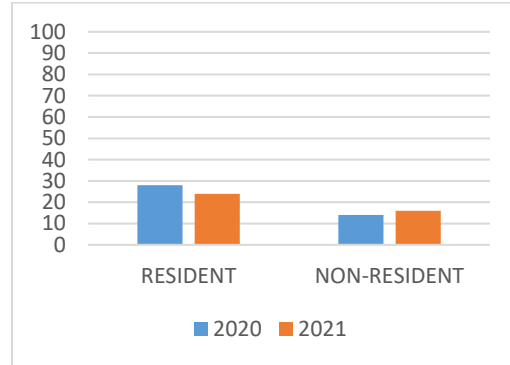
RESIDENCY TYPE ANALYTIC COMPARISONS

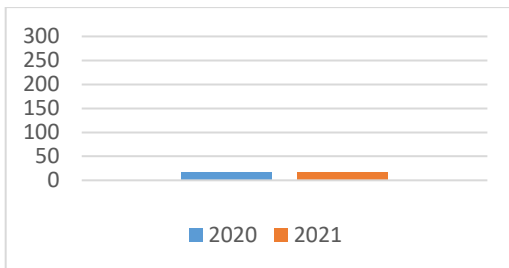
JANUARY MONTHLY TOTAL CALLS

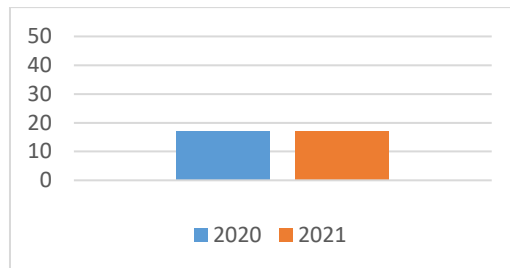
TOTAL CALLS IN WILD DUNES
