The following is a synopsis of some of the activities of the Isle of Palms Police Department during the month of October 2009.

Patrol

October 3, 2009 Just after midnight, an officer on patrol stopped a truck for an equipment violation. While speaking to the driver, the officer detected an odor of alcohol emitting from the vehicle. The driver stated he left his license at home in his backpack. The officer observed a backpack in the rear of the truck and asked the driver if the license was in that backpack. The driver retrieved his driver's license. A strong smell of marijuana was detected from another backpack located in the passenger side floorboard. A quantity of marijuana was discovered in that backpack, which belonged to the passenger. The passenger was charged with Simple Possession of Marijuana and released to the custody of his father with a courtesy summons.

October 3, 2009 An officer on patrol stopped to investigate a vehicle parked at the end of 25th Avenue and found it to be occupied by a female subject, who appeared to be under the influence of alcohol. Due to the subject's condition and inability to contact anyone to provide a ride she was taken into custody charged with Public Intoxication.

October 4, 2009 Officers responded to a front beach hotel where a female subject reported being assaulted by her female roommate. Hotel management wanted both parties to leave the premises so both were placed on Trespass Notice. The victim of the assault did not wish to pursue charges against her friend and both parties made separate arrangements to return to Georgia without further incident.

October 6, 2009 After conducting an investigation into an incident reported by a person receiving a massage in a Wild Dunes Spa, the masseuse was charged with Simple Assault. The subject turned himself in to the Investigator at the Detention Center.

October 7, 2009 Investigators located and identified the female suspect in an incident reported in September, where an elderly couple reported that a caregiver had forged over thirty checks that exceeded \$110,000. The suspect was taken into custody from her residence in West Ashley and transported to headquarters, where she cooperated with Investigators. The suspect has been charged with Breach of Trust, Forgery, Financial Identity Fraud, and Financial Exploitation of a Vulnerable Adult. She is presently in jail with bonds totaling \$175,000. A Search Warrant was conducted at the suspect's residence where evidence was removed, which indicates that the suspect was probably electronically transferring money from other victim's bank accounts to hers. The investigation is ongoing.

October 8, 2009 An officer responded to the Charleston County Detention Center to serve three Isle of Palms Arrest Warrants on a female subject stemming from a 2007 investigation, where the subject had stolen her boyfriend's father's wallet and used a credit card to charge almost \$2,700 to a front beach hotel. The subject was charged with Financial Transaction Credit Theft, Financial Transaction Credit Fraud, and Grand Larceny.

October 11, 2009 While conducting foot patrol on the front beach near the pier, an officer encountered four young looking subjects in possession of beer. Further investigation revealed that one female was a runaway from Atlanta, Georgia. All four were charged with Underage Possession of Beer, two were charged with Simple Possession of Marijuana, and one subject with Possession of Schedule I Controlled Substance, for a quantity of hallucinogenic mushrooms found in his possession. The runaway was also charged with False Information to Law Enforcement for failing to provide correct personal information to the officer regarding her true identity.

October 12, 2009 A male subject came to headquarters to report that his vehicle had been stolen. He stated that he had been consuming alcohol the evening prior and took a taxi home and when he returned to the Isle of Palms he was unable to locate the vehicle. His vehicle was located several days later on Sullivan's Island, where he had apparently left it.

October 12, 2009 An officer stopped a vehicle on 26th Avenue near Cameron Boulevard for an equipment violation and while speaking to the driver determined that her license to drive was suspended. A computer check also indicated that she was wanted in the state of Florida for outstanding check law violations, however they declined to extradite. The driver was cited for DUS.

October 12, 2009 An officer responded to a residence on 31st Avenue where a male subject reported that his ex-girlfriend had been in his residence threatening to take his dog, slash his tires, and to plant illegal drugs in his truck or house. Since the female never lived at the residence, the officer made contact with her and placed her on Trespass Notice.

October 13, 2009 An officer responded to a residence on 13th Avenue, where a resident reported that a male subject who had been watching her pets while she was out of town, has not yet returned a Wii electronic video game that she had loaned him, and further stated that she believes the same subject removed two guns missing from her home. A computer pawnshop records check indicated that the suspect had in fact pawned the two weapons locally. The property was recovered and Investigators made contact with him to make arrangements for him to turn himself in to face charges of Breach of Trust.

October 14, 2009 Officers responded to a residence on Seagrove Lane, where an assault had been reported. Officers discovered that a male subject had assaulted his friend's grandson for not quieting down while his friend was on the telephone. He was charged with Simple Assault.

October 15, 2009 Investigators arrested an employee of a local business for stealing gasoline that he was supposed to be putting in a company vehicle. The theft was caught by video cameras at the gas pumps. The employee surrendered himself to police and was charged with Petit Larceny.

October 17, 2009 Officers responded to a residence on Palm Boulevard regarding a dispute between roommates. While present, one subject began causing a loud and profane verbal rant on the front lawn, which resulted in the officer taking that person into custody, charged with Disorderly Conduct.

October 17, 2009 An officer on patrol on the front beach stopped to speak with a male subject walking on the sidewalk, who was in possession of a bottle of beer. After speaking to the subject it was determined that he was twenty years old. He was charged with Underage Possession of Beer.

October 17, 2009 Officers responded to Wild Dunes where security had reported a one- car accident near the Wild Dunes Reception Center. The first officer to arrive observed a vehicle straddling a landscaped median and a male subject attempting to push the vehicle from the median. The officer then spoke to witnesses who advised that the female driver of the vehicle was behind some nearby bushes. She was located and admitted that she had been driving the vehicle. Both subjects appeared to be highly intoxicated, soaking wet, and covered in sand. The driver submitted to several Field Sobriety Tests, which she failed. She was then transported to headquarters where she registered a .20% level of alcohol on the Datamaster machine, and was charged with DUI.

October 17, 2009 An officer on patrol of the front beach observed a vehicle operating recklessly on Ocean Boulevard. The vehicle was stopped and the driver was charged with Reckless Driving.

October 21, 2009 Investigators developed a suspect in an October 5th Burglary on Tabby Lane, where the suspect entered a home that was occupied by the homeowner and

stated that he was soliciting to power wash her residence. The homeowner was able to later positively identify the suspect through a photo lineup. The subject was charged with Burglary 2nd degree and Hindering, since he provided a fictitious name and date of birth. The same subject has also been charged for at least two separate Burglaries in Mount Pleasant.

October 22, 2009 Officers responded to a domestic dispute at a residence on 31st Avenue. It was determined that there had been a verbal altercation, which elevated to a point where a juvenile assaulted his father. The father did not wish to pursue charges, but stated that he would arrange for professional counseling to address family issues. Both parties involved agreed to go to bed and not have contact for the rest of the evening.

October 23, 2009 Just before 4 A.M., an officer stopped to investigate a very slow moving vehicle on the Connector. While the officer was speaking to the female driver he observed that she was very emotional and was crying. The officer also observed fresh bruises and scrapes and determined that the driver had just been assaulted on Sullivan's Island by her boyfriend. The officer made contact with a Sullivan's Island police officer, who responded to their location to investigate the assault.

October 23, 2009 Mount Pleasant Police Investigators recovered a laptop computer, belonging to a resident of Waterway Boulevard, at a pawnshop while conducting a Burglary investigation in their jurisdiction. Their suspect is the same suspect that this agency arrested on October 21st. Isle of Palms Investigators will be preparing additional Arrest Warrants for Burglary for him as well as a codefendant. This Burglary was committed the same day as the Tabby Lane incident on October 21st.

October 24, 2009 Officers responded to a residence on Hartnett Boulevard after a report of an assault at that location. Officers spoke to a female subject who reported that an intoxicated male acquaintance had thrown a water bottle at her while she was holding her two-year old child, and then pushed her into a door causing an injury to the child. The officers documented the injury and located the suspect who was taken into custody charged with Simple Assault.

October 26, 2009 An officer stopped a truck towing a trailer for speeding on Waterway Boulevard and after running a computer check of the driver determined that he was wanted in Florida for a probation violation. A check of the passenger indicated that he had a suspended license for failure to pay four traffic tickets. He was charged with NRVC 4 counts. Florida authorities declined to extradite, so the driver was released and cited for speeding.

October 28, 2009 At approximately 4:30 A.M., an officer on patrol observed a male subject walking on Palm Boulevard near Gate 1 of Wild Dunes and when the subject observed the police vehicle he appeared to walk faster. The officer stopped to investigate and determined that the subject was intoxicated. The subject stated that he was just let off on Palm Boulevard, and gave several different versions of why he was walking. While speaking to the subject another officer stopped on Palm Boulevard near 41st Avenue to

investigate a vehicle with fresh body damage parked facing southbound on the northbound shoulder of the road. The subject that had been stopped walking was determined to be the owner of this vehicle and was taken into custody charged with Public Intoxication and Leaving the Scene of an Accident.

October 28, 2009 A resident of Palm Boulevard reported a suspicious male subject near 26th Avenue knocking on doors, peering in windows, and trying door knobs to see if doors were unlocked. After receiving a physical description the subject was located and identified. The subject stated that he was selling magazines and was dropped off at noon by a company van and was to be picked up several hours later. The subject was issued a ticket for Failure to Have a Business License. Later, an officer stopped the company van that was on the island to pickup that subject and other magazine sales people dropped off in neighborhoods to sell magazines, and advised the driver and all ten persons in the van not to return unless they had a Business License. It was later determined that the company they were representing was bogus and used the guise of magazine sales to case residences for Burglaries to be committed later. Mount Pleasant and Sullivan's Island also reported the same type of situations in their jurisdiction.

Personnel/Community Relations

October 3, 2009 Officers provided traffic control for the annual Connector Run & Walk, which had over 1,400 participants.

October 15, 2009 Detective Tarr and PFC Thompson received a letter of appreciation from a family who they assisted when their vehicle broke down while they were visiting from Florida.

October 29, 2009 Sgt. Ambas spoke to all students attending the Isle of Palms Recreation Center daycare regarding Halloween Safety and distributed a bag of treats to each student.

October 29, 2009 Sgt. Ambas spoke to all students attending the St. Mark's Lutheran Church daycare regarding Halloween Safety and distributed a bag of treats to each student.

October 31, 2009 Officers assisted in giving out candy to children at the Recreation Center during their annual Halloween Party. The police department participated in the Pumpkin Carving Contest, competing between different departments in the city winning First Place!

October 31, 2009 For the month of October, officers discovered four businesses and six homes with open or unsecured doors. A total of three Victim of Crime Forms were issued to business or homeowners for various violations noted, or to advise them that an officer checked their business during the night while on patrol.

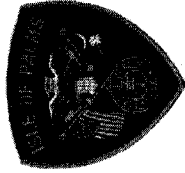
